Points to note from IPA-Budget 2020 to 2022:

 based at the Agency in Valenciennes (new post)
- Only limited budget for IPA-meetings;
 no money for participation in NSA- and NIB-networks in Valenciennes
- Technical Assistance to IPA-Beneficiaries is available:
 e.g. train driver licensing, registers, accident investigation, etc.
- Peer review-activities can presently not continue with IPA-Budget
- There is a dedicated budget for e-learning
