	<p>As of 25<sup>th</sup> May at 10:00, the citizens of Serbia and Hungary can freely pass the border between the two countries, without obligatory quarantine.</p> <p>As of 25 June a special regime for entry into the Republic of Croatia of persons coming from the Republic of Serbia, as well as from Bosnia and Herzegovina, Kosovo and North Macedonia is determined. They are required to stay in self-isolation for 14 days from the date of entry into the Republic of Croatia. This does not apply to passengers transiting through these countries.</p> <p>As of 6 July 6 AM Greece has closed the borders for Serbian citizens due to epidemiological situation.</p> <p><b>As of 7 July a mandatory 14-days self-isolation for all citizens of Montenegro entering Serbia is imposed.</b></p>	<p>have been taken and passengers in trains are obliged to wear a protective mask and gloves, to respect markings on/in trains (spot for entrance, moving around in train and exit) and respect social distancing, while trains are being disinfected. 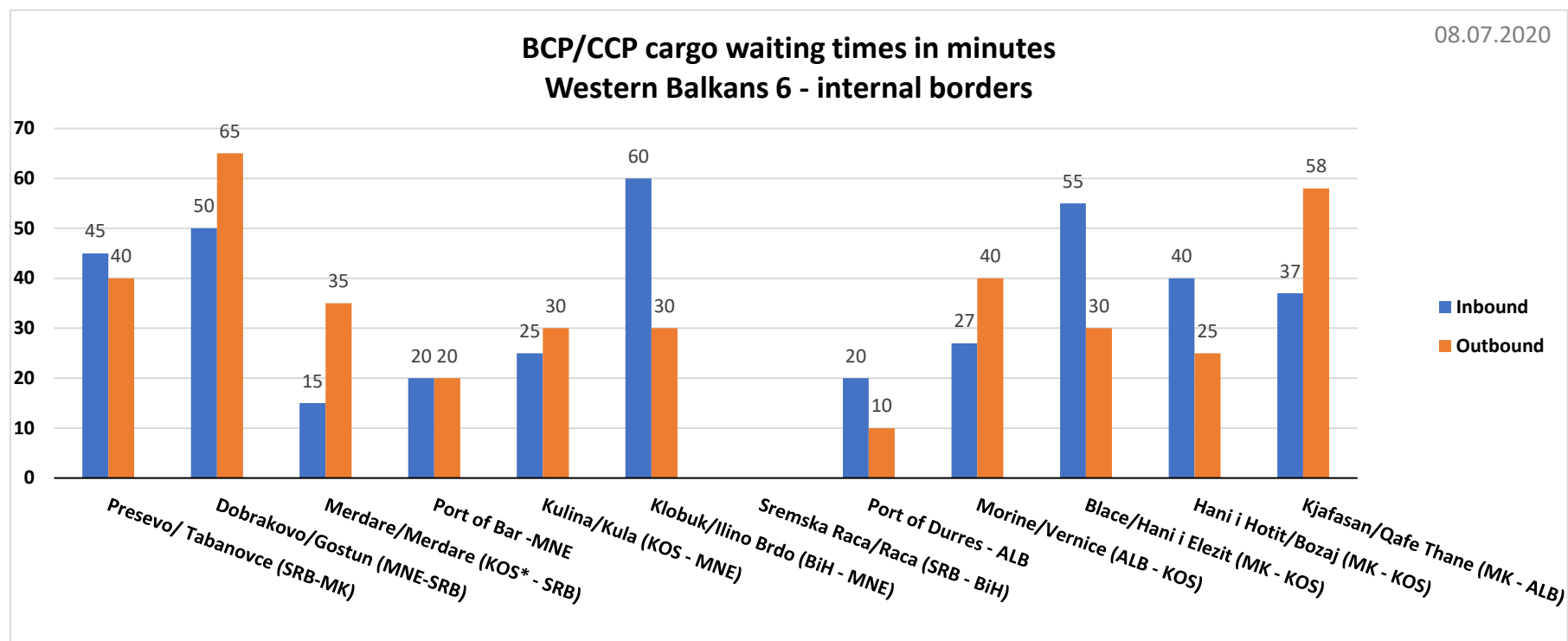
