Terms of reference for the ITS Sub-working group

Scope and expected achievements

The ITS sub-working group is set up under the umbrella of Road Technical Committee.

The ITS sub-working group shall assist the Road Technical Committee in all aspects related to Road ITS legal framework and deployment falling under the scope of the Transport Community Treaty (TCT).

For this purpose, the ITS sub-working group will elaborate a coherent set of concrete actions (Road Map) to be implemented by the South East European Parties in a coordinated and timely manner on deployment of ITS on road network in accordance with EU Directives and interoperability standards (e-tolling etc).

This Road Map will complement and reinforce Road Action Plan.

Method of work

ITS sub-working group shall consist of the representatives of the Contracting Parties of the Transport Community part of Road Technical Committee, dealing exclusively with ITS at the respective institutions/organisations.

Representative for DG MOVE covering ITS and e-tolling will be invited to attend the meetings of this sub-working group.

On a case by case basis, external experts and stakeholders will be invited to participate and/or contribute to its discussions and activities.

The ITS sub-working group is expected to meet at least as frequent as Road Technical Committee. Nevertheless, if need arises additional meetings of the sub-working group shall take place.
