EU SSMS Flagships



	1) By 2020, there will be at least 20 million zero, emission care and 80,000 zero
FLAGSHIP 1 – BOOSTING THE UPTAKE OF ZERO-EMISSION VEHICLES, RENEWABLE & LOW-CARBON FUELS AND RELATED INFRASTRUCTURE	1) By 2030, there will be at least 30 million zero-emission cars and 80 000 zero- emission lorries in operation.
	2) By 2050, nearly all cars, vans, buses as well as new heavy-duty vehicles will be zero-emission.
FLAGSHIP 2 – CREATING ZERO-EMISSION AIRPORTS AND PORTS	3) Zero-emission ocean-going vessels and large zero-emission aircraft will become market ready by 2030 and 2035, respectively.
FLAGSHIP 3 – MAKING INTERURBAN AND URBAN MOBILITY MORE SUSTAINABLE AND HEALTHY	4) Scheduled collective travel under 500 km should be carbon-neutral by 2030 within the EU.
<u>FLAGSHIP 4 –</u> GREENING FREIGHT TRANSPORT	5) Traffic on high-speed rail will double by 2030 and triple by 2050.
	6) By 2030, there will be at least 100 climate-neutral cities in Europe.
	7) Rail freight traffic will increase by 50% by 2030 and double by 2050.
	8) Transport by inland waterways and short sea shipping will increase by 25% by 2030 and by 50% by 2050.
FLAGSHIP 5 – PRICING CARBON AND PROVIDING BETTER INCENTIVES FOR USERS	9) By 2030, rail and waterborne-based intermodal transport will be able to compete on equal footing with road-only transport in the EU.
	10) All external costs of transport within the EU will be covered by the transport users at the latest by 2050.
