



## Introduction

All Six Western Balkans regional participants (Albania, Bosnia and Herzegovina, North Macedonia, Kosovo\*, Montenegro and Serbia) have had an adopted national road safety strategy in line with goals of First Decade of Action 2010-2020. Most road safety strategies provide targets and envisage monitoring reports. The effectiveness of road safety policies to date can be gauged by the number and reduction of road deaths. However, the numbers of road fatalities per million inhabitants are higher in the Western Balkans than the EU average.

In 2020, the Western Balkans region had 1171 fatalities which results with 625 lives saved for last 10 years. Every year a slight reduction has been reported resulting in a reduction of fatalities compared to the baseline year of 2010.



Figure 3: Change in percentage of road deaths in Western Balkans 2010 – 2020





Figure 4: Annual number of fatalities by Regional Partner, 2010 – 2020





**Figure 5:** Fatalities per million inhabitants in the Western Balkans 2020 with EU-27 average and Western Balkans average








Figure 7: Reduction of Fatalities in Bosnia and Herzegovina 2010 – 2020








Figure 9: Reduction of Fatalities in Kosovo 2010 – 2020
