What is TAIEX?

- An instrument dedicated to **EU partners**
- **Demand-driven** and **results oriented**
- Consists in **organising tailored events**
- With **experts from EU Member States** (**peer-to-peer**)
- For a better **understanding of the EU legislation, EU standards and best practices**
- And **builds institutional capacity**



Who can apply for TAIEX?

- **Officials** in Ministries dealing with community legislation
- Staff from **regulatory or supervisory bodies** and inspectorates
- Officials in **notified bodies** which implement or enforce legislation
- Officials in **Parliaments**, the **Judiciary** and **Law Enforcement Agencies**

...can introduce requests for TAIEX assistance

Contact: National Contact Points – EU Delegation

Who can benefit from TAIEX?

- **Civil servants** working in central public administrations
- **Judiciary** and **law enforcement** authorities
- **Parliaments** and civil servants working in Parliaments and Legislative Councils
- Representatives of **social partners, trade unions and employers' associations**



What is TAIEX?

Improving Transport Flows on Railway Border

Crossing Points March 2022, Montenegro



TAIEX Regional Workshop on 4th Railway Package

Aim: provide advice and guidance on '4th Railway Package'

Experts from: Italy and France

Participants: approx. 50 officials from ministries, railway authorities and other relevant stakeholders in the Western Balkans

Dates: 15/16 November 2022, Tirana, Albania

Organised at the initiative of Ministry of Infrastructure and Energy, Albania and Permanent Secretariat of the Transport Community

How? 3 main types of assistance:

1. WORKSHOPS

- Large number of participants (up to 100-120)
- Single or multi-beneficiary (regional events)
- At least 2 experts from 2 different EU Member States
- Max. 2 days (in-person)
- Maximum 3 half-days (online)



2. EXPERT MISSIONS

- Provide advice to the beneficiary' institution(s) on specific issues
- Max. 20 participants
- Max. 5 days



3. STUDY VISITS

- Up to 5 practitioners from beneficiary administration go to EU Member State administration
- Between 2 and 5 days



Modalities:

1. **In person:** participants exclusively join the activity **physically** in a location/venue
2. **Online:** participants join the activity exclusively in **virtual platform**
3. **Hybrid:** at least one expert and/or participant **in person** and at least one expert and/or participant join **online**

 - ✓ Conference room and/or online platform
 - ✓ Interpretation
 - ✓ Flights and accommodation
 - ✓ Catering




TAIEX in 2021



- Expertise mobilised **2,200+** times
- **Over 14,300** participants
- **57%** more attendees and **54%** more experts (compared to 2020)
- **92%** of participants rated TAIEX experts as **excellent or good** (data for 2020)

How to apply for TAIEX?

A final note says: "If you encounter any problem, please check the [Help guide](#) explaining the steps to fill in the application form online."
