## Enforcement of TDG as a multi-sectoral exercise / institutional structures and Administrative capacities

### Road Transport Task Force - Responsibilities/Functions

- Road Transport Task Force is a special temporary structure, for improving the level of road control of motor vehicles and trailers that serve for their economic use, for passenger and goods transport;
- The Road Transport Task Force is subordinated to the Minister of Infrastructure and Energy (MIE), which has 40 specialized employees;
- Road check control, in accordance with the established conditions of the legal acts and provisions, for the implementation of the legality of the activity of:
  - Terminals of regular passenger transport lines, as well as at taxi stands;
  - Places of passenger and freight road transport companies;
  - Places of cargo storage, loading and unloading of goods;
  - Other activities in the field of road transport, under the responsibility of the MIE



### Task Force – Resources and capacities

#### *Logistics*

- Vehicles - 8;
- Moving Machinery, for the control of means of transport in a wide spectrum (overweight, technical defects, etc.);
- Electronic scales (real-time measurement of vehicle weights);
- Ipad, body camera for terrain for each group.

#### *Human Resources*

- Road Check Inspectors - 30;
- Office (Administration) – 10 (Including General Director)
- Administrative measures Review Committee, with its members - 5

- Equipment for technical inspection- EuropeAid/138716/IH/SUP/AL, funded by EU



## Enforcement of TDG as a multi-sectoral exercise / Activities of cooperation on enforcement and future plans

- TAIEX application form - IPA, ENI, request, type of event workshop , study visit and et al
- Series of events for Albania - Review legislation, smart tachograph and roadside check, control and enforcement peer review
- Applicant- Ministry of Infrastructure and Energy / General Directorate Road Transport Services / Road Transport Task Force for Albania
- The main objective (goal) is enhance improving the citizens wellbeing, safety and security in our roads incl. the road-rail level crossings (LCs)
- Another objective is enforcement of road transport control or check including legal gap analysis and procedures including the TDG of goods

## Enforcement of TDG as a multi-sectoral exercise / Activities of cooperation on enforcement and future plans

- EU Acquis on the TDG by road (codification) - Uniform Procedures for check on TDG by road, codification, check, control, inspection, verification, formality by competent authority, reason of safety inherent in the TDG
- Transport Community Treaty law no.8, 26/2/2018 on the Treaty establishing the Transport Community and the guidelines on the TDG, in the publication from the permanent secretariat, Directives (EC) 2008/68, 2002/1999 and 2010/35
- Reports on monitoring from the secretariat, the implementing regulations on roadside checks - Annex 2 of directives on the checklist for the roadside control and its evaluation of the secretariat
- The Law 118/2012 on TDG, the participation on the AD HOC group of experts of the implementing regulatory provisions derived from the Guidelines of the TCT and MIE, DOCM, 2014 on the Inter-ministerial Committee of transport of dangerous goods and rules stipulated thereof
