11.30 – 13:00 | CSO Engagement in Infrastructure Projects and Policy Reform

The session will discuss how civil society can play a more active and structured role in two key areas of the transport sector: infrastructure projects and policy reforms. Firstly, it will discuss a case study, the Brenner Tunnel, showcasing how civil society can contribute to transparency, environmental oversight, and public participation in large-scale projects. Secondly, it will address reform processes and policy engagement, highlighting how EU CSOs have influenced legislative changes and sectoral strategies.

The final session will bring together key messages from the day and based on working group ideas, identify real opportunities for future twinning activities, regional workshops, and mechanisms for collaboration between civil society and institutions such as TCT, DG MOVE, DG ENEST, and OSF.
