

## 20th Road Technical Committee meeting

18 September, Villingen-Schwenningen, Germany

## **AGREED CONCLUSIONS**

- 1. The 20th Road Technical Committee (RTC) took place on 18 September 2025 in Villingen-Schwenningen, Germany, back-to-back with a study visit on tachographs and electronic tolling equipment at Continental Aumovio on 17 September 2025.
- 2. The study visit was highly valued by the RPs, who requested additional capacity-building events as follow-ups and expressed their readiness to collaborate and coordinate with the TCT Secretariat on future steps.
- 3. The RTC members noted the absence of the following representatives: Mr. Mensur Hodzic, Ms. Snezana Mastilovic and Mr. Danijel Kuzman from Bosnia and Herzegovina, and Mr. Gjynejt Mustafa from Kosovo\*1.
- 4. Ms. Olivera Stevic Ledencan, Chair from Serbia, welcomed the participants and wished a successful meeting. This meeting was held together with the members of the TCT informal group on tachographs.
- 5. The Agenda was adopted without comments from the RTC members.
- 6. Ms. Nerejda Hoxha, Road Coordinator, presented the Next Generation of Road Action Plan Western Balkans Monitoring Report 2025. Monitoring the implementation of the Next Generation of the Road Action Plan and supporting the region in the transposition of Annex I.3 Rules applicable to road transport of the Transport Community Treaty will remain central to the activities of the TCT Secretariat. All RPs will submit any updates to the presented report not later than 24 September 2025.
- 7. Progress on the ongoing TCT Technical Assistance to support the region in the assessment of setting up the National Access Points (NAPs) and National Bodies (NBs) in Regional Partners (RPs) was presented.
- 8. Following discussions with the NAPCORE network, four EU Member States—Austria, Croatia, Germany and the Netherlands—invited institutions from the region to participate in study visit

on the establishment of National Access Points (NAPs) and National Bodies (NBs). The RTC members expressed interest in visiting all these EU MS institutions. However, due to budget constraints this year and to ensure a balanced approach to EU Member State visits, the upcoming study visit will be organised in the Netherlands. The RTC members also requested the TCT Secretariat to explore the possibility of combining the remaining study visits with meetings of the Road Technical Committee in 2026.

- 9. Ms. Ljubinka Ivanovic, Road Project Officer, presented so far collected data needed for the preparation of the TEN-T Development Monitoring Report 2025 Western Balkans. Discussion highlighted the need for the preparation of Glossary of terms and the respective method of calculation for the new KPIs. In addition, RTC members advised to be included in future TODIS stakeholders structure aiming to ensure consistency in the monitoring approach and to avoid possible future discrepancies among submitted data.
- 10. Mr. Albert Kolgeci, Head of Division in charge of Transposition and Implementation of the EU Acquis, presented the Next Generation Action Plan on Social Issues and Passenger Rights followed by open discussion on the new measures of the Next Generation Action Plan on Social Issues and Passenger Rights. During the discussion, the RPs noted that further clarifications are needed and agreed to submit their comments by 24 September 2025.
- 11. Next Road Technical Committee will take place in Tirana during November 2025.
